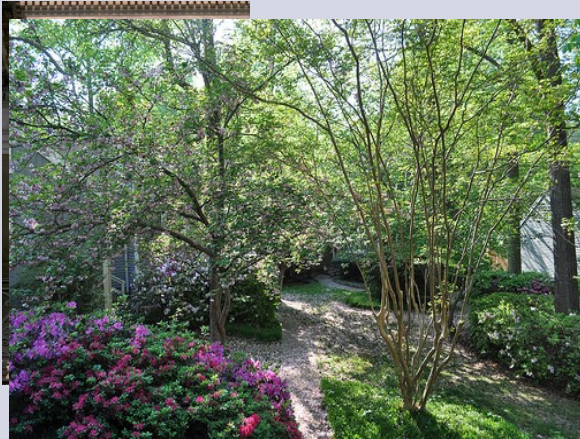


## President's Corner

### *Pine Straw in the News: Toni Cambier*

Pine straw has been a factor in two terrible fires during the last year, and the City Council has just passed a resolution that might affect Whitehall.

They have banned pine straw as mulch within 10 feet of multifamily rental units with flammable siding. Although some of our units are single-family dwellings, the majority are duplexes and many are rental units. Our siding is flammable, although not as serious a problem as the vinyl siding that figured in the two aforementioned fires. Fire Departments are working with

the state Building Code officials to extend the ruling to private family dwellings.

The ruling will not take effect until December 1, 2010, but it would seem practical to begin thinking about it now if you are planning to put any mulch around your unit. Our other concern about mulch near the foundation, of course, is to discourage termites. Here are some guidelines to keep in mind:

Termites live in the soil all around us. They are attracted to decaying matter and mois-

ture. The best thing you can do to discourage their entry into your unit is to put down a moisture barrier (plastic ground cloth) before you put down any kind of mulch. The best termite-resistant mulches have been proven to be cypress and redwood (not to be confused with ordinary hardwood that is dyed red). Melaleuca wood mulch is the best if you can find it. Gravel is an excellent alternative.

We will continue to have the landscaper put down pine straw mulch in the areas at the entrances, around the pool,

and along the roadways as long as it doesn't violate the 10 ft. rule; it is still the most economical mulch to use.

In the fall the Board will consider how we can work with residents to remove any pine straw that is close to units before the December deadline. Watch upcoming newsletters for more information.
